TRACK 7 EVENT SPACE POLICIES AND AGREEMENT

Track 7 Brewing requires a credit card to secure the event space for a particular date. The deposit will be applied to your total bill on the day of your event. Our cancellation policy states that if a contracted event cancels less than 3 weeks (21 days) prior to the event date your card will be charged 25% of your event estimate total.

Confirmed head count is obtained 2 weeks (14 days) prior to your event. If your actual guest count falls below that of your confirmed quest count, host will still be held to and charged for the confirmed minimum amount. If the minimum is not met, an open facility fee amount will be added to the final bill.

This contract guarantees the event space for 3 hours. You may have access to the room 30 minutes prior for set up and have 30 minutes at the end for breakdown. If your group requires additional time you may request an additional hour at the rate of \$150/hr. This is at the discretion of the taproom manager and based on availability.

All event space, beverage and related services are subject to applicable taxes and service charge (currently 20%) in effect on the date(s) of the event.

All prices and beer selection are subject to change based on availability.

Full payment of your event will be due at the conclusion of your event. Accepted forms of payment are cash or credit card. Checks will not be accepted. If a check payment is attempted the credit card on file will be charged to settle event balance.

ALL OUTSIDE BEER, WINE AND SPIRITS ARE STRICTLY PROHIBITED. ANY PARTY CAUGHT BRINGING OUTSIDE ALCOHOL ONTO THE PREMISES WILL BE FINED \$500 FOR VIOLATION OF OUR LIQUOR LICENSE AND ALCOHOL COMPLIANCE POLICY.
