Growler Club Agreement

The Growler Club Applicant "First Party," agrees to enter into this contract with **Track 7 Brewing Co.**, known as "Second Party" on - **the contract submission date** (contract must be received between 10/8/18 – 11/4/18).

This Growler Club agreement is based on the following provisions:

1. First Party is 21 or over with valid ID
2. First Party pays \$599 + tax
3. First Party receives a single membership to Track 7 Growler Club, which includes one 64 oz personalized Miir Growler.
4. First Party receives 2 growler fills (totaling 128 oz) per week (Mon-Sun) for each week of 2019
OR
one (64 oz) growler fill & one (64 oz) 4pk of special release beer
5. Weekly benefits must be used in the week they are allotted.

Below are the Growler Club membership details:

- Growler can be filled at all Track 7 Brewing Co. locations: Curtis Park, Natomas, or The Other Side.
- Growler can be filled any day that Track 7 Brewing Co. is open during the regularly posted hours unless Track 7 Brewing Co. establishes restrictions during special events.
- Growler fills subject to core beer board availability and Track 7 discretion on special release beer.
 - Core beer: Panic IPA, Hoppy Palm Pale Ale, Bee Line Blonde Ale, Blood Transfusion IPA, Left Eye Right Eye DIPA, Daylight Amber, Nukin' Futz Chocolate Peanut Butter Porter
 - Special release beer: limited availability small batch beer ie sours, fruited beers, collaborations, etc.
- Growler Club members have the option to substitute 1 of their weekly allotted growler fills for 1 special release 4pk. 4pks become available the Sat of the can release at all three locations.
- Growler Club members may have advance access privileges enabling them to pick up 1 special release 4pk on the Fri prior to the public can release.
 - **Advanced access is only available at the Curtis Park Taproom.**
 - Members are limited to redeeming benefits for 1 special release 4pk in advance on a first come first serve basis while supplies last. Members must return for the official Sat can release to purchase additional 4pks.
 - Members will be notified via social media if a special release is available for advanced purchase.
- Growlers can only be filled using the Miir growler issued to member. No other outside growlers or Track 7 glass growlers can be substituted for the Miir growler.
- Growlers can only be filled by member or their designated alternate for the year (ID required at time of fill).
- Growler Club memberships cannot be re-funded, re-sold or transferred to any other individual.
- Growlers lost, damaged, or destroyed are the sole responsibility of the Growler Club member.
- Growler Club membership begins January 1, 2019 and ends December 31, 2019.

This agreement is subject to the laws and regulations of the state of California. In submitting membership application online, First Party agrees to terms of the Growler Club contract with Second Party.
